EACH GRANT AWARD IS \$150,000 OVER A TWO-YEAR PERIOD, WITH TOTAL RESEARCH FUNDING OF \$1.5 MILLION. RESEARCH GRANT AWARDS WERE SELECTED BASED ON RECOMMENDATIONS FROM THE FOUNDATION'S INDEPENDENT MEDICAL ADVISORY BOARD AFTER A RIGOROUS GRANT REVIEW PROCESS.

TOPICS WERE SELECTED BASED ON EVALUATION RESPONSES FROM PAST EDUCATION PROGRAMS AND FEEDBACK FROM PATIENT ADVISORY COMMITTEE MEMBERS. PROGRAMS INCLUDED THE ANNUAL NEW & EMERGING TREATMENTS SERIES (4 WEBINARS), LEUKEMIA Q&A (CHRONIC AND ACUTE WEBINARS) AND A WEBINAR FOCUSED ON CLINICAL TRIALS.
