RESEARCH GRANT AWARDS WERE SELECTED BASED ON RECOMMENDATIONS FROM THE FOUNDATION'S INDEPENDENT MEDICAL ADVISORY BOARD AFTER A RIGOROUS GRANT REVIEW PROCESS.

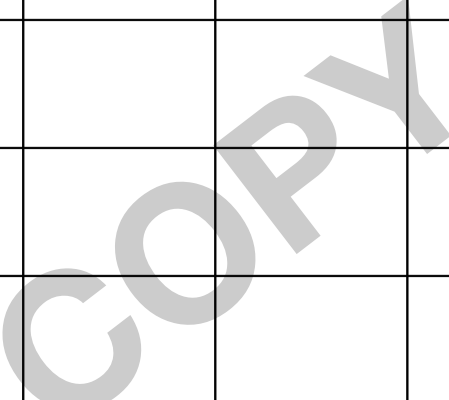

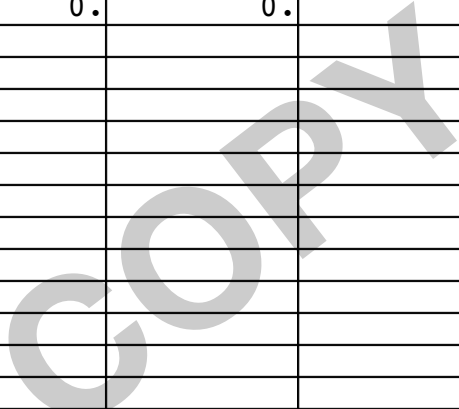
